



Ohio Star Legacy testifies for stillbirth tax credit



Doug Livingston, Heather Johnston Welliver, Justin Welliver and Beth Swartz testified at the Ohio Statehouse Tuesday, March 13, in front of the House of Representatives Ways and Means Committee.

The Ohio House of Representatives is considering a one-time, \$2,000 tax credit for stillborn babies, as a way to recognize the children and grant some financial relief to grieving families, thanks to the work of the Ohio Chapter of the Star Legacy Foundation.

Ohio Star Legacy members testified Tuesday, March 13, before the House Ways and Means Committee on House Bill 507.

Chapter Chair Heather Johnston Welliver and Secretary Justin Welliver, of Westerville, spoke about their daughter, Lydia Joanne, who was born still Nov. 6, 2014.

"She was perfect, with big flipper feet, long fingers a cute button nose and dark hair like her Dad's. She was perfect but she was no longer alive," Johnston Welliver told committee members. "Weeks later, after my milk had come in with no baby to feed, the hospital bills started to arrive. Those bills are painful enough with a living child, but when you have no baby at home, they are heartbreaking."

Ohio averaged 900 stillbirths a year between 2003 and 2016, according to the state Department of Health. The numbers are not budging. According to the Centers for Disease Control and Prevention, Ohio ranked seventh in the country for the number of stillbirths in 2015.

Nationally, every year, about 26,000 babies are stillborn, defined as death in utero after 20 weeks gestation.

Ohio allows families to receive stillbirth certificates, but the state offers little other help.

"The harsh truth is that a child that never takes a breath is not recognized as a person, is not covered by insurance and cannot be claimed as a dependent under the current tax law," Justin Welliver said.

Doug Livingston testified about his daughter Emma.

"The placenta that nurtured our Emma just separated while we slept. We strived in every way for a healthy pregnancy. There was no trauma and, ultimately, no suitable explanation for our loss. We were told: 'sometimes it just happens.' Two-thirds of parents like us get that line."

Nurse Beth Swartz talked about the hurdles grieving parents face when they leave the hospital.

"These families leave this sacred space, only to be challenged with situations where their children are not recognized: The acquaintance who says, 'At least you are young. You will have more kids,' the denial from their employer for bereavement leave, no birth certificate being issued by the state, and not being able to claim these babies on their taxes. Additionally, they are faced with an immense financial burden: hospital bills, funeral expenses, lost work revenue, are just to name a few."

The Ohio chapter is pushing for a stillbirth tax credit because costs related to stillbirth are not all covered by insurance, and because we want a symbolic gesture recognizing stillbirth. The bill could also provide an opportunity to educate lawmakers about the prevalence of the deaths.

Support the Ohio stillbirth tax credit: Contact your Ohio representative

To pass the \$2,000 tax credit for parents of stillborn babies, we need your help. Please tell your state representative that you support House Bill 507 and you'd like them to vote for it.

(We'll contact senators when the bill is being considered there.)

Whether you are the parent of a stillborn child, a friend or family member or a citizen looking for an important cause, you can call or email your legislators.

To make it easy, use the Voter Voice tool. Just fill out your name and address, and it'll send emails to representatives for you.

A few tips for drafting your own emails, or making a call.:

- Keep it short and to the point.
- Register to vote first. (Representatives' staff may check this.)
- Make sure you include your name and address, as well as your support for House Bill 507.
- Make it personal, using the name of your baby and as much of your story as you'd like.
